- 1. I Richard Cave of Stanford in the County of North[hamton] esquire being whole of body and of perfect mind and memory the 17 day of June in the 28th year of the reign of our sovereign Lord King Henry the eight do ordain and make this my present last Will and Testament in form following
- 2. First I bequeath my soul to almighty God maker and Redeemer of all the world our blessed Lady St. Mary the virgin and to all the holy company of heaven
- 3. And my body to be buried in the parish church of Stanford before the rood loft there as my wives Elizabeth and Margaret late deceased now lie
- 4. And I give and bequeath to the mother church of Lincoln 12d
- 5. And as concerning the order and disposition of all and singular goods and chattels movables as also my debts plate and jewels that I have I give and bequeath in manner and form following
- 6. And where I have made before this time diverse bargains and covenants with diverse and sundry persons as well for the several marriages of diverse of my sons as for the marriages of my daughters I notify and declare by these presents that I have well and truly performed all and singular bargains covenants and agreements which on my part were to be performed according to such writings or promises as have been by me made for the same so that there is nothing at this time of my part remaining unperformed which of my part ought of right to be performed to them or to any of them
- 7. Also I give and bequeath to the repair of Stanford church five pounds and my second chalice of silver and pearl gilt

8. And also I will that my best chalice all gilt shall remain and be in the keeping of my som Thomas Cave and that my priest that shall sing for me and for other my friends to say mass with the same and to be at his rule and keeping

- 9. Also I give and bequeath to my daughter Elizabeth Wyrley towards the marriage of her children one hundred pounds sterling whereof I have paid to my son Wyrley her husband fifty and four pounds sterling
- 10. Also I will that my daughter Dorothy Smyth shall have to the marriage of her children one hundred marks sterling
- 11. And also I will my daughter Chauntrell shall have to the marriage of her children one hundred marks sterling as well to them that be married as unmarried whereof I have paid to her forty pounds
- 12. And also I will my daughter Prudence Croke have forty marks towards the marriage of John Croke
- 13. Also I will that my daughter Bryget Tauffelde shall have forty marks sterling to the marriage of her children and a chain of gold which was my wife's which chain of gold I have delivered to her
- 14. And also I will that my son Sir Ambrose Cave shall have one hundred marks sterling And he to be good to his brothers and sisters all as he shall see in them most need of help and friends
- 15. And also I give to my son Doctor Francis Cave one hundred marks sterling And he in like wise to be good to all his brothers and sister which shall have need of friends
- 16. Also I give to my son Bryan Cave one hundred pounds sterling
- 17. And also I will that all priests and gentlemen and all other honest men shall have meat and drink every man that will come to my burial
- 18. And poor people to have pence apiece it to be provided for them by the advice of my executors as the time of the year shall require
- 19. And also I will that my neighbours of Stanford shall have meat and drink and 2d apiece both old and young And that to be done what day my executors shall think best
- 20. Also I give and bequeath to every godchild that I have alive at my departing 2s
- 21. And also I will that every priest that says mass and dirge for my soul at my departing shall have 8d and every clerk 2d
- 22. Also I give to Robert Coton my servant five pounds sterling and every year a livery beside 8 kye or steres grass in Over Stormesworth field and four oxen in Nether Stormesworth by Barnehill during his life to do me service And also I do give him his house and croft that he dwells in without paying any rent for the same during his life the rent of which house and croft is 2s 4d by year and he to be good to my son Thomas Cave which shall have the manor of Stanford after me And it is my will that my son Thomas Cave shall give to the said Robert Coton his twelve beasts grass in the Over Stormesworth field and Nether

Stormesworth as aforesaid during his life without any rent paying for them or for his house or croft during his life

- 23. Also I give and bequeath to Thomas Nycolls my servant four marks sterling
- 24. And to every woman servant that I have at my death that has done me service one year before my death shall have 26s 8d towards their marriage to pray for my soul
- 25. And also I give to John Andrew/Dawes and Greenborough towards their marriage 20s apiece to pray for my soul whereof I have paid to Dawes 10s
- 26. And also I give to all my servants men and women that do me daily service and have done one year whole at my death shall have beside their wages to pray for my soul my father my mother my wives Elizabeth and Margaret Caves souls and for all Christian souls every one of them 13s 4d towards their marriage
- 27. Also I give and bequeath to every child of my cousin Thomas Cave's towards their marriage five marks sterling whereof two of them have had ten marks before the making hereof besides that I gave them five score they to divide among them my cousin has six children which comes to twenty pounds sterling
- 28. Item I give and bequeath to my Lord Abbot of Selby to have there mass and dirge for my soul my father my mother soul and for all Christian souls five marks and to master prior there 20s and to every master that is a priest there to say mass and dirge for my soul and all Christian souls ten shillings and to every novice 3s 4d
- 29. Also I will that there be bestowed in wax yearly ten shillings to find candles to burn in the church of Stanford upon my candlesticks there before the sacrament of the altar there and the reed loft there And the same ten shillings to be received of William Symonds farm of Swinford yearly parcel of the 26s 8d that I have yearly of him for the farm that he has of me there of the Commandry of Dyngley which ten shillings I will shall be spent there yearly during so many years as hall be to come by my Indenture after my death And the rest of my rent and years of the same Indenture I give to Richard Cave the son of my son Thomas Cave during the terms and yearly the ten shillings in wage to be spent according to my will before rehearsed And if there by any wage saved yearly that then I will it be given to the Sepulcure there to be to the mending of the tapers there spent at Easter
- 30. And also I will that my son Anthony Cave shall immediately after my death have all such closes and pastures in Pulteney which I have of the lease of Sir Thomas Pulteney knight during so many years as shall then have to come in the same paying the whole rent and all other charges as I am bound to pay during my lease
- 31. Also I give and bequeath to my Lord of Pypwell to say mass and dirge for my soul forty shillings and to every priest there 6s 8d and to every novice there 3s 4d to pray for my soul and all Christian souls
- 32. Also I give and bequeath to my Lord of Combe to say mass and dirge for my soul 20s and to all other priests and novices to say masses and dirge for my soul and all Christian souls 26s 8d amongst them

33. Also I give and bequeath to every house of freres in Northampton Coventry and Leicester to say mass dirge and a trental of masses for my soul my father my mother my wives Elizabeth and Margaret souls and for all Christian souls 13s 4d

- 34. Also I will give and bequeath to my son Thomas Cave immediately after my death all my household stuff in Stanford both corn plows carts gear and horses occupied to and this the plough and my milk kye swans swine wa? And 8 oxen for the wain carts and ploughs at Stanford aforesaid and all other stuff in my house of Stanford And also I will that my said son Thomas Cave shall keep or cause to be kept my said household as well men servants as woman servants at Stanford by the space of one year next after my death they and every of them doing him service for the same as they have done to me And to pay them their wages as they have been accustomed to have and to take and have meat and drink there if they be content to abide and take the same And they that will not abide to have my bequest paid unto them beside their wages if any be behind unpaid and so depart
- 35. And I will that my son Thomas see there be once a year an obit kept for me at Stanford to the which I will that all my executors or such as conveniently may come and repair unto that day to have both meat and drink that come to my dirge and mass of Requiem for my soul and other before named there And that my son Thomas Cave or whoever be dwelling in the Manor of Stanford for the time of twenty years shall at his or their proper [own] costs and charges find and give honest harbour and lodging meat and drink to all or such my executors which may conveniently come to my said obit and also their servants and horses such lodgings and horsemeat as for them shall be convenient for the space of two days and two nights within the manor of Stanford and no longer but at the pleasure of the said Thomas or of him that shall dwell in the said manor of Stanford
- 36. Also I will that my executors at the day of my burial or else within six years after my death immediately give to poor people or to highways or to the marriage of poor maidens to the discretion of my executors to give forty pounds
- 37. Item I give to poor Richard my boy in the kitchen towards his living forty shillings
- 38. And also I give and bequeath to my son Brian Cave after my death my lease that I have of the Commander of Battesford and Dyngley of the friary be paying or discharging all such charges as I am bound to do by my lease to me granted by their common? Seal of St. Johns
- 39. Also I give and bequeath to my son Richard Cave all my lease interest and term that I have in a pasture called Blakden in Eltyngton of the lease of the house of Pypwell he paying the rent and such other charges as I am bound to do for the same And the convent? Seal of the same I delivered to him the 23rd day of January in the 20th year of the reign of our foresaid sovereign Lord King Henry the eight And over this give and bequeath to my said son Richard Cave all such interest and terms as I have of the parsonage of Lilborn of the house of Leicester paying the rent and all other charges as I am bound to do for the same
- 40. Item I give to Thomas Hardyman forty shillings And I give to his two brothers twenty shillings apiece of them
- 41. Item I give to Katheryn Andrews and her sister Margaret Cave daughters of my son Edward six pounds sterling that I lent to their mother in her widowhood which is not repaid to me the 4th day of February Anno 29 Rex Henry VIII equally to be divided between them

42. Item I will where as I had before in this last will and testament given and appointed to my sons Thomas Anthony Richard and Brian four hundred ewes and lambs by their sides or else four hundred ewes and four hundred hogerells [pigs] to be divided equally among them coming out of my flock in Stormesworth fields for certain considerations me now moving I will that this will and testament in that point shall be void and of none effect In consideration whereof I give to my son Anthony one hundred ewes and lambs with them And is the ewes have no lambs then I will he have to his ewes one hundred hogerells to be delivered to him by my executors coming out of my flocks in Stormesworth aforesaid And in like manner I give and bequeath to my son Richard one hundred of ewes and lambs with them And is the ewes have no lambs then I will he have to his ewes one hundred hogerells to be delivered to him by my executors coming out of my flocks in Stormesworth aforesaid

- 43. Item I give and bequeath to my son Thomas Cave all the residue of my sheep beasts and cattle whatsoever they be in the towns and fields of Stormesworth and Stanford aforesaid
- 44. Item I give and bequeath to my son Brian all manner of great beasts and cattle whatsoever they be that I have going in my farm of Yugwardby [Ingarsby] without anything paying for the same and also my grey sc?oned horse that I have of my Lady Skevington
- 45. Item I give and bequeath to my son Thomas all such interest leases and terms as I have in Cokhall and Cotehyll pastures in Eltington [Elkington] by several leases of the Abbot and convent of Pypwell to have to him during the terms contained in the same And also I give him sixteen score ewes and thirty beasts to have in a stock towards the storing of the same fields to such use and intent as is contained in a pair of indentures made between the said Thomas of the one part And my sons Francis and Brian Cave of the other part And for such further intent and purpose as is here after specified and declared that is to say that my said son Thomas shall pay yearly to Richard Payne my servant 26s 8d and his livery during the life of the same Richard Payne in part of recompense of his painful and service done by him unto me
- 46. And also I will that my said son Thomas shall permit and suffer my sons Sir Ambrose Cave and Francis Cave to have grass and pasture in the said field of Cokhilles for twelve geldings winter and summer equally for every of them six geldings without any things paying for the same during their lives if the term of years so long continue by force of the lease aforesaid so that they take the same to their own use only without letting the same or any part thereof to any person or persons
- 47. Item I will that my executors shall cause a bridge and causeway of stone for carts to pass over to be made at Brownes Man? As shortly as they can have stone and workmen to be made after the patron of Swarstonbridge
- 48. Item I will that where my brother John Saxby owes to me certain sums of money to the sum of fifty pounds and above I will that he shall pay ten pounds thereof to my executors And all the residue of the same debt I give him towards the marriage of his daughter Clemence my goddaughter And at the payment of the same ten pounds I will my executors deliver to him three bowls of silver which I have of him as pledge
- 49. Item I give and bequeath to my son Anthony Cave two hundred pounds sterling of such money as he owes me

50. Item I give and bequeath to my son Richard Cave to his own use one hundred pounds sterling And towards the marriage and preferment of his children which he has the day of my departure two hundred pounds sterling at the delivery whereof I will he shall put in surety to my executors that the said money shall be ready and forthcoming to the marriage and preferment of his said children at such time as they and every of them severally shall accomplish the age of 21 years

- 51. Item I give to Alice Gardiner my servant five pounds sterling
- 52. Item I give to Thomas Flekyn of Lylborn forty shillings sterling
- 53. Item I give to Joan Warde late servant with my son Richard Cave twenty shillings
- 54. Item I give to my cousin Thomas Cave all such debt as he owes me And I will that my executors shall give him 40s and my old gown furred with fox
- 55. Item whereas I have given afore in this my last will to my daughter Dorothy Smyth one hundred marks sterling to the marriage of her children I will my executors shall give her fifty marks more of such debts as her husband owes me to the intent aforesaid
- 56. Item I give and bequeath unto Katheryn Andrews my son Edward Cave's daughter ten marks sterling And also I give to her sister Margaret Cave ten marks sterling
- 57. Item I give to the vicar of Lilborn the parson of Oakley and Thomas Downhall and to every of them all such debts as they and every of them owe unto me jointly severally
- 58. Item I give and bequeath to my godson Laurence Cave son of my cousin John Cave a rent of 5s 4d by year which the said John his father should pay to me and to my son Thomas Cave and to the heirs of my said son Thomas upon bargain and sale of certain lands made between me and my said son Thomas of the one part and the same John Cave of the other part as by a pair of indentures thereof to be made shall plainly appear To have the said rent after my decease to the said Laurence and to his heirs forever
- 59. Item I will that when the vicarage of Stanford Hall happen to fall void that my executors shall present to the same Sr Robert Aleyn my chaplain And if he refuse it then they to appoint another able priest to the same Sr Richard Cowper now vicar of Clyfton And if he refuse then
- 60. Item I will that when the chantry of Swynfords Hall be void that my executors present to the same then they to appoint another able priest to the same
- 61. Item I will that when a chantry that I have in the Newark at Leicester of the gift of the abbot of Leicester shall be void that then my executors present to the same Thomas Tarry if he will be priest And if he refuse then they to appoint another able priest to the same
- 62. Item I will that my executors shall cause to be made for every son and daughter that I have at this day on life two salts of silver whole gilt with a cover to every pair of salts gilt the weight of every pair with the covers to be of ten pounds sterling to be all of one weight and fashion and to be delivered to every one of my sons and daughters by my executors
- 63. Item I give to my son Sir Ambrose one gelding which he will choose

64. Item I give to my son Richard the cloth and the fox fur that I bought for a new gown for myself

- 65. Item I will that all such towns the shires as have had my chantry before this time as appears by bills of the same? the day of my burial as much more as they had the last time And the curates of every town to say or sing dirge and mass the same day and as many as shall receive my charity and alms to be at the same dirge and mass in every town as they dwell
- 66. Item I will that my executors shall buy more black and such other necessities for my funeral and enterrement as by their discretion shall be thought convenient
- 67. And also I will give and bequeath to my son Thomas Cave my bason and ewer of silver partial gilt and three bowls with a cover partial gilt and a case to them and two of my best gilt salts with the cover and also my spoons with one of them all gilt and 7 of them partial gilt with the apostles of the ends
- 68. And also I will that every poor man which owes me the sum of 20s and not above non take it but let them pray for my soul and all Christian souls
- 69. And all such as owe me above the sum of twenty shillings they to pay the same at days with favour according to their abilities And if they be poor some part of the debt to be remitted and forgiven
- 70. And also I give and bequeath to my son Bryan Cave both my leases the old and the new of my farm of the manor of Yugwardby [Ingarsby] which I have by two convent seals for years to come And he to pay to my Lord abbot of Leicester the rent for the manor and pastures and for the tithe of Hungarton in like manner as I am bound to do by indentures with the convent seals
- 71. Also I will my son Brian shall have all my bedding apron and all my household stuff there with all pots of brass pans carts geyres all mares which be used to draw my carriage there and all other corn and stuff there
- 72. And also I will that all my plate beside that I have afore given to my son Thomas Cave shall be evenly divided between my son Thomas Cave Doctor Francis Cave Anthony Cave Richard Cave and Bryan Cave to be divided and parted by weight as shall be thought best by their advices
- 73. And also I will and bequeath my apparel my best furred gown and my best jacket of velvet to my son Thomas Cave and he also to have the best of one of my black summer gowns whereof one is lined the fore quarters of black satin? And the other summer gown lined in the fore quarters with tawny damask
- 74. And that gown that Thomas does leave of my two summer gowns that gown I do give my son Bryan Cave
- 75. And also I give my son Bryan Cave my black gown furred with black cony
- 76. Item I give and bequeath to my son Richard Cave my best black gown furred with Irish lamb and bogy before And also I give my son Richard my best jacket of black damask and one of my doublets of tawny satin

77. And also I will and bequeath that there be given of my goods yearly during the space of forty years every year at my obit day thirteen shillings and four pence first to the priest to say dirge and mass 4d and to the clerk 2d and the rest to the helping and finding of them that be poor and have most need of help to pray for my soul my father my mother my wives Elizabeth and Margaret Cave's soul and for all Christian souls

- 78. And also I give and bequeath to every one of my sons and their wives my sons-in-law and their wives fine black to make them gowns And all men servants and women servants in my own house at Stanford and my priests to have black gowns
- 79. Also I give and bequeath to the vicar of Swynford forty shillings and to my chantry priest there twenty shillings
- 80. And to Sr Richard my priest and Sr Robert to every one of them to pray for my soul twenty shillings
- 81. And I renounce & forsake all other will and wills testament and testaments before this time by me made and affirm this present writing to be my last Will and testament
- 82. And executors of the same I ordain and make my son Thomas Cave my son Doctor Francis Cave and my son Brian Cave Whom I will and charge to see this my present Will and testament well and truly observed performed fulfilled and kept as they will answer before God
- 83. The residue of my goods my will performed and not bequested I give to my son Thomas Cave my son Doctor Francis Cave and my son Brian Cave And my said executors I will and charge to see this my present Will performed
- 84. And overseers of this my present Will and testament I ordain and make Edward Montagu sergeant at law Sir Ambrose Cave my son knight of the Rhodes my son-in-law John Croke and Robert Chauntrell
- 85. And I give to every of my said executors and supervisors which shall take upon them the execution of this my last Will and testament ten pounds sterling to the intent that they shall see this my will truly performed
- 86. And I will that if any ambiguity doubt variance or question at any time hereafter shall happen to arise between any of my said sons or other persons to whom I have given willed or bequeathed anything in this will in for or upon the expounding interpretating or declaring of any legacy or bequest here before comprised in this my last Will and testament that then every such doubt variance or question to be ordered expounded and declared by the said Edward Montagu Sir Ambrose Cave John Croke and Robert Chauntrell or the overseers of them without any suit at law for the same according to the true meaning of this my present Will and testament
- 87. And my mind and will is that every of my said sons and daughters and child's children and all other person to whom I have willed or bequeathed any sum or sums of money or other things by this last Will and testament shall hold themselves contented with such legacies and bequests as I have made given or bequeathed to any of them by this my last Will and testament without demanding or requiring any other thing

88. And if they or them or their children or any other person or persons by their pronouncement or by the procurement of any of them do an thing to the breach or interruption by suit or otherwise of this my Will that then they and every of them and their children shall take no benefit nor profit by this my Will and testament but all such legacies and bequests as I have made to them and every of them and to their children by this my Will shall be to them and every of them so shall interrupt sue break or let this my Will utterly void and of no effect against them and their children And the same to be disposed after that for the wealth of my soul by my executors
