## Will of Ann Frost 1802 (CheshireRO)

Text

1. This is the last Will and Testament of me <u>Ann Frost of Macclesfield</u> in the County of Chester <u>Widow</u> made and published this fifteenth Day of March in the year of our Lord one thousand Seven Hundred and eighty Seven in manner following

- 2. First I order and direct all my Just Debts funeral expences and the Charges of probate of this my Will to be paid off and discharged by my Executors hereinafter named from and out of my personal Estate and Effects immediately after my decease
- 3. I Give Devise and Bequeath unto Thomas Frost of Manchester in the County of Lancaster Turner and David Frost of Macclesfield aforesaid Cotton Manufacturer and the survivor of them and the Executors and Administrators of such Survivor as well as all and Singular my Household Goods and furniture as also all Money due and owing to me on Mortgage Bond or otherwise howsoever as also all other my personal Estate of what nature or kind soever Upon Trust that they the said Thomas Frost and David Frost and the Survivor of them and the Executors and Administrators of such Survivor shall and do with all convenient speed after my decease sell and dispose of all and singular my said Household and other Goods and furniture for the best price or prices and most Money that can or may be reasonably had or gotten for the same And also to collect and call in money due and owing to me on Bond or otherwise at my Death as aforesaid And do and shall stand and be possessed of and interested of and in the Money which shall arise by such Sale or Sales and Disposition of my said Household Goods and furniture And also such Money that may be Due and owing to me on Mortgage or Bond or otherwise as aforesaid And also of and in all other my personalty as aforesaid In trust to pay apply and divide the same unto and Amongst my Sons Peter Frost the said Thomas Frost the said David Frost George Frost, Joseph Frost, James Frost, and my Daughters Ann Frost and Sarah Wife of John Parkinson to and for her sole and seperate use and benefit independent of her said Husband their Executors Administrators and Assigns equally share and share alike Nevertheless to be paid and come due in manner and at the times herein after mentioned that is to say That the respective parts or shares as aforesaid of them the said Thomas Frost and David Frost shall become due to them their Executors Administrators or Assigns immediately after my Decease and that the respective parts or shares as aforesaid of my said sons Peter Frost, George Frost and Joseph Frost of Sarah the Wife of John Parkinson with Interest for the same shall become due and be paid and payable unto them their executors Administrators or Assigns respectively on twelve months notice in writing being given to them the said Thomas Frost and David Frost and the survivor of them or the Executors and Administrators of such Survivor for payment thereof And as for and concerning the parts or shares of my said son

James Frost and my said Daughter Ann Frost both now under the age of Twenty one years I order and direct that the said Thomas Frost and David Frost and the survivor of them to put and place out the same at Interest upon such Government real or other Security or Securities as they shall in their discretion think best and pay and apply the yearly interest produce and proceeds thereof in the manner herein after mentioned that is to say The interest of the part or share of the said James Frost unto him and his Assigns either untill the Determination of his Apprenticeship or age of Twenty one years at the discretion of the said Thomas Frost and David Frost and the survivor of them And when and so soon as the said James Frost shall attain the age of twenty one years or otherwise shall have served his Apprenticeship as aforesaid Then and in such case I order and direct my said Trustees and the Survivor of them to call in the part or share of him the said James Frost so by me given as aforesaid and pay and apply the same with all such interest as shall be then due unto the said James Frost and his Assigns to and for his and their own use and uses And as to the interest of the part or share of my said Daughter Ann Frost I order and direct my said Trustees to pay the same unto her Assigns untill she shall attain to the Age of Twenty one years And when and so soon as the said Ann Frost shall attain her Age of Twenty one years then in such case I order and direct my said Trustees and the survivor of them to call in the part or share of her the said Ann Frost so by me given as aforesaid and pay and apply the same with all such interest as shall be then due unto my said Daughter Ann Frost and her Assigns to and for her and their own use and uses

- 4. And my Will and meaning is that if the said Joseph Frost, James Frost and Ann Frost or any of them shall happen to die unmarried and before they shall respectively become entitled to their parts or Shares as aforesaid Then and in such case the part or share and parts and shares by me to them hereby respectively given together with such Interest thereof if any shall be due in the meantime of his her or them so dying shall go to and be paid and payable unto and amongst all and every my Child and Children then living equally share and share alike and as to for and concerning all the rest residue and remainder of my real or personal Estate that I may be possessed of at the time of my decease and not hereinbefore by me Disposed of I give and bequeath the same unto and amongst all and every my said Child and Children equally share and share alike
- 5. Provided and my Will and meaning is that it shall and may be lawful to and for them the said Thomas Frost and David Frost and the survivor of them and the Executors and Administrators of such survivor to reimburse and satisfy themselves and every of them by with and out of the said Trust Monies all such Costs Charges Damages and Expenses whatsoever which they or either of them shall or may sustain incur expend or be anyways put into for or by reason or means of the Trusts and Execution of this my will and that one of them shall not be answerable for the Acts Deeds and Defaults of the other of them but each for his own Seperate Acts Deeds Defaults Heirs Executors and Administrators and not otherwise
- 6. And I do hereby nominate constitute and <u>appoint the said Thomas Frost and David Frost Executors</u> of this my last Will not doubting but they will duly perform the same as my Trust in them reposed hereby revoking all former and other Will and Wills by me at any time heretofore made and I do declare this only to be my last Will and Testament
- 7. In Witness whereof I the said Ann Frost the Testatrix have hereunto set and put my hand and seal the Day and Year first within written
