**Text** 

In the name of God Amen

- 1. I Mary Mills of the parish of St. Nicholas Deptford in the county of Kent widow being of a perfect sound and disposing mind, memory and understanding do make publish and declare this to be my last Will and Testament in manner and order following (that is to say)
- 2. Imprimus I give and bequeath unto my <u>daughter Jane Mills spinster who now lives at</u> home with me all my wearing apparel of all sorts whatsoever
- 3. Item all the rest and residue of my goods chattels and personal estate with my stock in trade and all the money I have of may have due or belonging to me at the time of my decease with all other effects whatsoever and where so ever and of what nature kind or quality so ever the same may be or consist I give and bequeath unto my son Isaac Mills hatter who likewise lives at home with me and my aforesaid daughter Jane Mills to be equally divided between them share and share alike
- 4. Subject nevertheless to the payment of all my just debts and funeral expenses (but if in case either my aforesaid son or daughter should die before me then and in such case the survivor of them shall enjoy the whole of my goods chattels personal estate and effects aforesaid
- 5. And I do hereby make constitute and appoint them my said son Isaac Mills and my daughter Jane Mills joint executor and executrix of this my last Will and Testament
- 6. And I do hereby revoke and make void all other Wills and Testaments by me at any time heretofore made and do ratify and declare these presents and none other to be and contain my whole last Will and Testament
- 7. In Witness whereof I have hereunto set my hand and seal this twenty fourth day of October in the twenty fourth year of the reign of King George the third over Great Britain etc. and in the year of our Lord one thousand seven hundred and eighty three
