Text

1. This is the last Will and Testament of me <u>Henry Robinson of the City of York Tea Dealer</u> made the twenty seventh day of February one thousand eight hundred and thirty nine

- 2. I give and bequeath unto my <u>son James Robinson</u> all my <u>shares</u> and interest in the North of England joint stock Banking Company and also the sum of <u>one hundred and fifty</u> pounds sterling
- 3. I also give and bequeath to my son Henry Robinson the sum of fifty pounds sterling
- 4. and to my daughter Hannah Robinson the sum of two hundred pounds sterling
- 5. I give and devise all my Right share and interest of and in the Messuages or <u>Dwellinghouses situate in Stonegate in the City of York</u> now in the respective occupations of James Cloak and Henry Smith and late the property of Mr James Croft deceased the Grandfather of my said Children with the Rights Members and appurtenances thereunto belonging unto my <u>daughter Ann Catherine Robinson</u> (by my second wife) her Heirs and assigns
- 6. I also give and bequeath unto my said <u>daughter Ann Catherine Robinson</u> all my <u>shares</u> and Interest in the York City and County Banking Company and also the sum of <u>six hundred pounds</u> sterling
- 7. I also give and bequeath unto <u>Jane Perfect my housekeeper</u> in case she shall be living with me at the time of my decease the sum of <u>fifteen pounds</u> sterling
- 8. And I direct that the said several Legacies and sums of Money hereinbefore given and bequeathed shall be paid transferred and retained within twelve calendar months next after my decease
- 9. All the <u>rest</u> residue and Remainder of my monies goods chattels personal estate and effects of what kind so ever save and except such articles of Furniture Plate Linen and China as I have already given and appropriated to and for the use of my said two daughters and are specified in certain Schedules or Inventories signed by me and given to them after payment of all the just debts which I shall owe at the time of my death my

funeral and testamentary expenses and the said several Legacies hereinbefore given and bequeathed I give and bequeath unto and amongst my said <u>Children James Robinson</u> <u>Hannah Robinson and Ann Catherine Robinson in equal shares</u> and Proportions

- 10. And I appoint my said <u>daughters Hannah Robinson and Ann Catherine Robinson joint executrixes</u> of this my will
- 11. And I hereby revoke all other wills by me hereto fore at any time made and declare this present writing to be my last Will and Testament
- 12. In Witness whereof I have hereunto set my hand and seal the day and year first herein before written
