

ROLLE OF STEVENSTONE.

ARMS:—Or, on a fess dancettée between three billets Az., each charged with a lion rampant of the field, as many bezants.

CREST:—A cubit arm erect vested Or, charged with a fess indented double cotised Or, in the hand a flint stone ppr.

SUPPORTERS:—Two leopards regardant Gu. besantée, ducally crowned Or.
