- 6s 8d to the poor in the alms house in Stow-on-the-Wold

- 7d apiece to each godchild

- 7d to each servant living with his at his death

- rest to wife Alice

Total fortune: - ca. £90, 2 teams of horses, livestock, + rest

- 1. The 28th day of November Anno Domini 1612 I Thomas Roocke of Bledington within the diocese of Gloucester yeoman being sick in body but of good and perfect remembrance thanks be given to God for it do ordain and make this my last Will and Testament in manner and form following
- 2. Inprimus I commit my soul into the hands of almighty God my creator and redeemer and my body to the earth to be buried in Christian burial And as for my worldly goods which the Lord of his gracious goodness has lent me I do dispose as follows
- 3. Item I give and bequeath towards the repair of the church of Bledington 6s 8d
- 4. Item I give and bequeath to the poor of the same parish the value of 6s 8d in corn
- 5. Item I give and bequeath to my **son** John Rooke my team of horses at Bledington with their furniture and the ploughs and carts after the decease of Alice Rooke my now wife
- 6. Item I give and bequeath to Rowland Checker and Elizabeth his wife all my part of the team of horses at Maulgersbury with the ploughs carts and all other furniture to the same belonging all my household stuff being at Maulgersbury aforesaid (my beasts and sheep there only excepted)
- 7. Item I give and bequeath to Dorothy Rooke my daughter four score pounds

- 8. Item I give and bequeath to Thomas Farrant and Anne his wife one quarter of seed barley to be delivered to him when he does set up his team upon his living
- 9. Item I give and bequeath to my sister-in-law Agnes Rooke widow 8s 4d and to her three children viz. John Agnes and Elinor Rooke 20s apiece
- 10. Item I give and bequeath to Agnes Ancott one heifer of two years old to be delivered to her within five years next after my decease
- 11. Item I give and bequeath to every one of my children's children 20s apiece to be paid to them within five years next after my decease
- 12. Item I give and bequeath to the poor in the alms house at Stowe Would 6s 8d
- 13. Item I give and bequeath to every one of my godchildren 7d apiece
- 14. Item I give and bequeath to every one of my servants which shall be dwelling with me at the time of my decease 7d apiece
- 15. All the rest of my goods and chattels moveable and immoveable unbequeathed I give and bequeath to Alice Rooke my wife whom I do make my sole executrix of this my last Will and Testament my debts paid my legacies performed and my funeral discharged
- 16. And I do appoint John Wade Thomas Hawkins and John Johnson my overseers and they to have for their pains taken herein five shillings apiece
