- 3. First I do give & bequeath to the almshouse of Stow 10d?
- 4. Item I do give & bequeath to the repair of the church of Stow 12d
- 5. Item I do give & bequeath to my brother Hu? a cur? & grist corn
- 6. Item I do give & bequeath to his four children to each of them a sheep
- 7. Item I do give & bequeath to the three children of my brother William? Checker to each of them a sheep
